ORDER

In continuation of this Council's earlier institute-transfer order no.WBSCT&VE&SD /TED/ 2020-21/02075 dt: 14 December, 2020 and no.WBSCT&VE&SD/TED/2020-21/02088 dt:21 December, 2020, with the approval of the competent authority, transfer of institute in respect of the **8(eight)** additional 2nd year students of Diploma courses in Engineering & Technology of different Government and Government Sponsored polytechnics, is hereby allowed without change of their branch and year of study vide **Annexure** subject to fulfilment of the following eligibility criteria. A transferred student must

- have valid registration on the date of issuance of transfer memo by the polytechnics.
- submit written letter of consent for issuance of transfer memo.
- have regular candidature in his/her polytechnic.

Willing transferred students are advised to submit their '**letter of acceptance**' of institute-transfer **online (by e-mail)** to their present Institute latest by **26-12-2020**. Non-receipt of '**letter of acceptance**' from the transferred students by their present polytechnics within the specified dateline will be considered as '**Not willing to avail transfer**'. **Principals/Officers-in-Charge** of the respective polytechnics "**from which**" the students have been transferred are requested to issue transfer memo against received '**letter of acceptance**' from the willing transferred students and mail those to the respective polytechnics positively by **28-01-2021**. **Principals/Officers-in-Charge** of the respective polytechnics "**to which**" the students have been transferred are requested to allow admission to the transferees on the basis of the received transfer memos at the earliest following standard norms. Additional guideline for the **Principals/Officers-in-Charge** of the respective polytechnics "**from which**" the students have been transferred follows, for smooth & fast execution.
