The Competent authority of the Council [WBSCT&VE&SD] invites sealed tenders for procurement of small envelopes & big envelopes as per sample for Practical, Project exam, etc. relating to Higher Secondary ,(Voc.) exam, 2022

In view of above, bonafide & reputed bidders are hereby requested to submit tender as per the specification, given as under :

#### Scope of Work:

The required quantities of envelopes

1) Small envelopes = 80,000 nos. & Specification:- As per Sample

2) Big envelopes = 30,000 nos. & Specification:- As per Sample

Sealed envelopes as mentioned above should be submitted super-scripting "Tenders for Envelopes " in the Tender box located at 4<sup>th</sup> Floor of WBSCT&VE&SD office. The bid should be addressed to the CAO, WBSCT&VE&SD and to be submitted at above mentioned address on or before 09/02/2022 , 4.00 p.m.

- 1. It is mandatory to submit the bid along with credential of such successful supply to organization as mentioned in eligibility cause.
- 2. The Council reserves the right to change the requirement by (+) or (-) 20% of the bid quantity mentioned.
- 3. The Bid Document should contain
- i. Self attested copy of Valid Trade License
- ii. Self attested copy of PAN Card of Company
- iii. Self attested copy of Professional Tax Clearance Certificate
- iv. Self attested copy of GST Registration Certificate
- v. Certificate of Credential of Similar Kind of Work from the previous /existing Institutions in support of eligibility Clause.
  - 4. The rate quoted will have to be inclusive of all charges whatsoever.
  - 5. An EMD of Rs. 25000/- (Rupees Five Thousand) is to be paid in favour of "WBSCT&VE&SD" payable at Kolkata and the successful bidder has to submit Rs 20,000/- (Rupees Twenty thousand as security deposit on receipt of Letter of acceptance.
  - 6. Last date of submission of bids is 09/02/2022 within 12 noon and will be opened on the same day at 3:30 pm.
  - 7. The Council reserves the right to cancel any or all the tenders if so required without assigning any reason thereof.
  - The items have to be supplied within 7 days of issuance of work order. Failing which the work order will be cancelled and order will be given to next lowest eligible bidder without assigning further reason.
